2 **I, CHRISTOPHER AEMISEGGER, declare as follows:**

4 **1. My name is Christopher Aemisegger. I will be a senior at De Paul**  
5 **University in Chicago, Illinois.**

6  
7 **2. I will be taking the LSAT on October 4<sup>th</sup>, 2003 because I would**  
8 **like to apply to law school this year.**

10 **3. I went to an LSAT presentation class that TestMasters put on at**  
11 **De Paul University to learn more about their LSAT courses sometime last**  
12 **year. I liked the presentation and because I had some experiences with Kaplan**  
13 **and The Princeton Review, I believed that TestMasters was the best LSAT**  
14 **preparation course for me because it contained more substantive material than**  
15 **the other courses offered.**

17 **4. A few months ago, I started looking at schedules for the LSAT**  
18 **classes because I wanted to make some decisions and plans for the summer. I**  
19 **went on-line and typed in the domain name www.testmasters.com, which is**  
20 **what I believed the TestMasters' website address would be. It took me to the**  
21 **website of a company that I believed I was looking for: TestMasters, the**  
22 **company that offered comprehensive LSAT preparation classes. I looked at**  
23 **their schedules for the Chicago location. I saw that their classes started in**  
24 **August. Based on this schedule, I made some very comprehensive plans. I**  
25 **decided to move back to Michigan, which is where I am from, get a summer**  
26 **job there and then return back to Chicago in time to take the LSAT Course.**

2 5. By mere chance, two or three weeks later, I happened to be  
3 looking on line for some websites that would give me information about the  
4 timeline of applying to law school. As I was doing this research on the Google  
5 search engine, I came across an ad on Google for TestMasters. I clicked on the  
6 ad and I was utterly shocked. I realized that this is the company for which I  
7 had been looking and not the other company. This TestMasters website  
8 contained a tremendous amount of information about their LSAT program  
9 and their faculty members. Moreover, they had a detailed course syllabus,  
10 FAQs about their program, testimonials from previous students who listed  
11 their beginning LSAT score and their actual LSAT score after having taken  
12 the TestMasters LSAT course, a record listing the numerous perfect LSAT  
13 scores of the individual who authored the TestMasters LSAT course and so  
14 much more, whereas, the other Test Masters website that I had originally  
15 looked at (the incorrect one), behind their LSAT link, listed only locations  
16 and one schedule for each location. This schedule was the same schedule that  
17 was displayed for many other cities in which they advertised LSAT classes,  
18 which I thought was strange. I thought how can a company advertise an LSAT  
19 program nationally, charge close to \$1400 for the program, and then offer no  
20 substantive information about their program, with the exception of one  
21 schedule on their website? It was especially strange in light of the fact that they  
22 had much information about their preparation courses for the other exams  
23 such as the SAT. I was very alarmed because I thought this company was the  
24 top at teaching LSAT, yet they had this website with absolutely NO  
25 SUBSTANTIVE INFORMATION.

27 6. When I finally found the correct TestMasters, by mere chance, at  
28 first I was very distraught and extremely angry because after looking at their

1 schedules, I realized that the class in which I wanted to enroll had already  
2 started and I had already missed two classes. I did not know what to do  
3 because I had already re-located to Michigan and I had secured a job. I could  
4 not move back to Chicago now.

7 7. I immediately contacted TestMasters. I spoke to a representative  
8 about enrolling in the TestMasters' LSAT course. However, the closest class to  
9 me was in Ann Arbor, two hours away from my house. At this point, I had no  
10 choice but to sign up for that class, even though it was so far and I had already  
11 missed two class meetings.

12  
13 8. I am very angry because believing that www.testmasters.com was the  
14 company I was looking for, even though it was not, has totally incurred upon  
15 me a big financial burden and most importantly, it has hurt my educational  
16 plans and goals. If this company would have somehow provided a link to the  
17 correct TestMasters, I would have stayed in Chicago where I could have  
18 attended the TestMasters' class, located only minutes from my old apartment.  
19 If I had been made aware that they were a different company, I would not  
20 have moved to Michigan and I would not have gotten a job. Now, I am living  
21 in Michigan, commuting for two hours to get to my class twice a week, and I  
22 am working at a job that I cannot suddenly quit. This means that so much time  
23 is now taken out of my days because I have to commute to class and I have to  
24 work, whereas, if I had known that the first company was the wrong company,  
25 I would have stayed in Chicago, not gotten a job and devoted all of my time to  
26 studying for the LSAT.
