15 what I had remembered TestMasters offered and a higher price for the class. There
16 was no more information about the class on the website but the schedule.

18 3. I was shocked to see that the price of the course was higher, yet the
19 number of lecture hours of the class decreased and the program looked to be of such
20 an inferior quality compared to the TestMasters program that I had researched last
21 and this year.

23 4. I then called the number that I had in my file and the TestMasters I
24 was looking for explained to me that they were a totally different company than the
25 Test Masters located at www.testmasters.com


27 5. If I had not called TestMasters to find out why their website changed
